### **§ 163-3. Schedule of permit fees.**

A. The following schedule of fees is hereby fixed, determined and established as being the fees to be paid to the Township of Hainesport for the issuance of all road opening or street excavation permits. Should any additional costs be incurred by the Township of Hainesport due to the permittee's operations or negligence, including administrative, engineering, inspection and legal costs, the permittee shall reimburse the Township for all costs incurred. The permittee shall be required to post adequate funds in escrow to reimburse the Township for costs of the Township Engineer's inspection. Any excess moneys shall be remitted to the permittee upon approval and acceptance by the Township Engineer of all final, permanent road restoration work in accordance with the standards set forth herein. All costs shall be paid by the permittee prior to the issuance of a permit by the Township Engineer, as provided herein.

#### **Schedule of Fees:**

Area of Opening (square feet)

0 to 100 square feet	<b>\$500.00</b>
100 to 4,000 square feet	<b>\$500.00</b> , plus \$0.90 for each square foot over 100 square feet
Over 4,000 square feet	<b>\$3,740.00</b> , plus \$0.40 for each square foot over 4,000 square feet

For a bona fide utility, regulated and licensed by the New Jersey Board of Public Utilities and subject to the payment of public utility gross receipts and franchise taxes, the schedule of fees may be modified in a separate agreement with the Township that will guarantee that any road opening and restoration work performed by the utility shall conform to the requirements set forth herein.
