**ORDINANCE AUTHORIZING PURCHASE OF COAH PROPERTY
(113 Tartan Lane)**

WHEREAS, the Hainesport Township maintains certain dedicated off-budget funds to administer low and moderate income housing units pursuant to its agreement with the Council On Affordable Housing (COAH); and

WHEREAS, N.J.S.A. 40A:12-5 authorizes a municipality to purchase real estate; and

WHEREAS, the land located at 113 Tartan Lane, being Block 101.07, Lot 006 on the Official Tax Map of Hainesport Township, is presently a COAH housing unit

WHEREAS, the Township wishes to purchase said real estate to preserve the COAH nature of said housing unit;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hainesport in the County of Burlington, State of New Jersey that the COAH Administrator of Hainesport Township is hereby authorized to receive the delivery of an appropriate Deed in favor of the Township of Hainesport in exchange for the sum of \$82,829.00 plus closing fees not to exceed the sum of \$3,000.00.

SECTION III:

This Ordinance shall take effect immediately after proper passage, publication and approval as provided by Law.
