

HAINESPORT TOWNSHIP COMMITTEE MINUTES

December 12, 2023 6:30 P.M.

This meeting is called pursuant to the provisions of the Open Public Meetings Law. This meeting of December 12, 2023 with instructions for internet access was included in a meeting notice sent to the Burlington County Times and Courier Post on August 11, 2023 and advertised in said newspapers on August 16, 2023, and August 17, 2023 respectively posted on the website and the bulletin board in the municipal building on August 10, 2023 and has remained continuously posted as required under the Statute. In addition, a copy of this notice is and has been available to the public and is on file in the Office of the Municipal Clerk.

F. **NJSP In-Person Report** – November 2023

SSgt. Antenucci, NJSP - reported that there had been an arrest on November 26th for an armed robbery that occurred at a Facebook marketplace meet up. The suspect has been arrested and charged. He recommends that people find safe, well-lit spots in the community to exchange goods, utilize community safe trade spots and bring a friend. This was an isolated incident. He said the troopers enjoy all the Hainesport events they attend including the Menorah lighting, Christmas events and the Veterans lunch. They appreciate being invited. **Mayor Clauss** thanked the troopers for doing a great job.

Mayor Clauss and the Committee presented Committeeman Levinson with a plaque for his 3 years of service on the Committee. **Mr. Levinson** thanked them and said he hoped he had been a positive impact on the town.

7. ORDINANCES

A. **ORDINANCE 2023-10** – Amending Chapter 104, of the Code of the Township of Hainesport, Entitled "Land Use" and Various Redevelopment Plans, To Incorporate the Addition of Cannabis Business Uses as Permitted Uses as Authorized in Chapter 77 of the Code (**Public Hearing and Final Adoption**)

OPEN: Motion: Committeeman Montgomery. Second: Committeewoman Evans. All yes

Mr. Montgomery clarified that this ordinance changes some of the definitions we had originally approved. It does not change anything as far as what we are doing with the cannabis use. **Mr. Gillespie** explained that this ordinance amends the Land Use Code to include or exclude the permitted uses that were previously approved.

B. **ORDINANCE 2023-11** – Adopting Redevelopment Plan for Certain Property Known as Block 72.01, Lot 1 and a Portion of Greenwood Avenue Proximate to Block 72.01, Lot 1 (Haines Mobile Park) (**Public Hearing and Final Adoption**)

OPEN: Motion: Committeeman Levinson. Second: Committeeman Montgomery. All yes

Township Planner Scott Taylor –explained this is involving the Haines Mobile Home site. Over the last couple of months, the Committee has identified it as an Area of Rehabilitation. This sets forth to rezone the 3.18-acre parcel from Industrial, which would not permit reinvestment or neighborhood expansion, to this new zoning which will facilitate reinvestment. This modifies to permit new design standards and improve existing infrastructure design. It will provide amenities and a variety of housing types, including up to four affordable housing units, which is consistent with the Master Plan. Mr. Montgomery asked if it will be 10 new homes, of which four could be affordable housing. Mr. Taylor

answered the 'up to four' will be determined in the Redevelopment Agreement. There are also some vacant lots that may be chosen for the affordable units. **Mr. Gillespie** added it can be one of the units already existing. There is a compatibility among the units, so as with most inclusionary sites, you won't know which ones are deed restricted. **Mrs. Gilmore** asked if this will need to go before the Joint Land Use Board. Mr. Taylor responded yes. This is just for zoning. Public notice, subdivision and site plan approval will be done at the Joint Land Use Board.

Their next meeting is January 29th at 7 pm at the Street Community Center. She wished all the residents Happy Holidays and Happy New Year. She thanked the Committee and the staff for everything they have done this year.

Donna Casey, 1703 Cottage Street – thanked SSgt. Antenucci, the State Police and the Committee for spending time and helping at the events. The Veterans lunch was a huge success. We are fortunate to have a lot of businesses willing to donate food. Thanks to our Mayor's Wellness Campaign grant that Leila Gilmore applied for, we received \$1,000. We used it to sponsor 10 kids for the Healthy Kids running event and the Dance Experience hip-hop class for Seniors which is on its third session.

While the amendment process is focused and not too easy, the ConCon process is not focused and opens our Constitution to drastic revision and potential replacement. 12. COMMENTS FROM THE ADMINISTRATOR

Ms. Kosko reported that she submitted the 2024 American Rescue Plan Firefighter Grant request for \$63,195. That includes eight sets of protective gear and replacement of a non-compliant oxygen fill station located at the firehouse. The Grant request also committed \$10,000 in matching Township funds, which generally is budgeted by the Committee every year. She thanked Chief Bozarth for his assistance with the Grant application.

The Municipal Clerk's Association of New Jersey and Lori Buckaloo, who is the Director of Government Affairs for the League of Municipalities, are working on reforming OPRA (Open Public Records Act). Advocacy efforts to reform OPRA began in September with all 565 New Jersey towns providing data related to the OPRA requests we receive each year. In an effort to educate and inform the community on the statute and to bring full circle the premise of OPRA - government transparency, she would like to provide a link on the Clerk's page on the municipal website that includes the OPRA statute, its exemptions, our OPRA form, the annual document request logs received over the past 3 years and the current year's log, which would be updated monthly. She asked the Committee for any input. The Committee members expressed agreement with the idea. She added that the reform efforts are getting stronger and there is absolutely a need to reform OPRA and the statute.

Our Reorganization meeting for 2024 is Tuesday, January 2nd at 6:30pm with the regular meeting following at 7pm. She wished everyone a happy and safe Holiday season with their families.

Mr. Gillespie wished everyone well and thanked the Committee for the privilege of working with Hainesport. He wished Bruce Levinson all the best.

14. COMMENTS FROM THE COMMITTEE

Committeewoman Evans – recognized Hainesport's holiday spirit with the Menorah lighting, Christmas tree lighting and gingerbread house decorating events.
