

# HAINESPORT TOWNSHIP COMMITTEE MINUTES

November 7, 2018 7:00 P.M.

# A. Good Samaritan Award

Mayor Masciocchi presented a Good Samaritan Award to Zachary Lawrence for walking the younger children in his neighborhood to and from school because the complimentary bus rides were discontinued in that area. Zachary took it upon himself to do this and it made the parents and children feel much safer because of his actions. Also present to honor Zachary were School Board President Mike Morrelli, Middle School Principal Tom Simonet and Administrator of School Mike Blake. Middle School Principal Simonet also said a few comments about Zachary and the award.

# B. 2018 Best Practices Questionnaire

Ms. Kosko said that the township will receive 100% of the ETR aid because we scored high on our Best Practices and have already submitted it to the state.

# C. 2019 CDBG Grant Project

Ms. Kosko said that the Community Development Block Grant is available to communities every two years and we received notice from the county that applications are due December 21st. She said that originally the township wanted to make an application for demolition of the buildings at the Creek Turn/Kleiner property but found out that it is just outside the block tract to be eligible for the grant. Therefore, she would like the committee consider an application for installation of sidewalks, curbing and traffic calming for various roads within Hainesport Proper. She gave examples of areas that would be eligible for the grant. The funding range should be between \$65,000 and \$80,000 so the maximum award we will receive is \$80,000.

10. COMMENTS FROM THE PUBLIC (Comments are limited to 5 minutes)

**Jim Horowitz,** 47 Hastings Lane – congratulated Gerry Clauss for winning the election yesterday. He stated that Gerry had run a clean campaign and was proud of the way both candidates had run their campaigns. He also said that he hopes the way their campaigns were run will set a precedent for the future. Mr. Horowitz said when he first decided to run for committee he set two goals for himself; one was to win and the other was to run a clean campaign that he could be proud of and bring some civility back to the democratic process. He thanked everyone for their consideration.

## 11. COMMENTS FROM THE ADMINISTRATOR

Ms. Kosko said that the Street Scan was here today collecting our streets data and will be finishing up tomorrow. The data collected will take about two weeks and the program will be launched in several phases. The images will be uploaded and available not only to us but also to the public. She received approval from the Burlington County Department of Land and Resource Conservation to change the scope of the 2016 Burlington County Municipal Park Development Grant. The application was submitted to the county and approved for a little bit over \$190,000 and that was for the installation for the poured in place surfacing at the Rancocas Park. Ms. Kosko met with Scott Taylor and Greer Reinalda, the town planners, and met with Mary Pat Robie and Matt Johnson with the BC Department of Resource Conservation to discuss that park and the grant funds. The grant also included a pavilion at the park. The county is willing to put a gazebo on their side, next to the boat ramp. This will free up a lot of funds made available to us through the grant. She had two playground vendors come out and both of them recommend that the township does not do the poured in place at that location. The life of the poured in place far exceeds the life of the playground. Ms. Kosko is hoping the committee would consider changing the scope of the

project to include, which the county has approved, installing a new 26 x 45 foot pavilion to replace the current one at the municipal building. Our needs have far exceeded the size of that gazebo. She received a price for the pavilion, labor, and concrete as well as a shelter system, ADA walkways, tables and receptacles at Rancocas Heights Park. The quote, under state contract, is a little bit over \$190,000. She is seeking the committee's authorization to move forward on that project and change the scope of the 2016 Municipal Park Development Grant application. Mr. Costa then asked Ms. Kosko if anything had been said about the boat ramp. She said she had met with Mary Pat and Matt to rebirth that issue. There was some discrepancy as to who owns the ramp and as well as the paper street that ends at the ramp. Ms. Kosko received formal letters from Hainesport Fire Company and Mt. Laurel Fire Department advocating for the ramp to be fixed so that it can be used for emergency response and training. Ms. Kosko thinks the county is going to advocate fixing the ramp via emergency management funds. Mrs. Gilmore asked what needed to be done now to go forward with the pavilion and Ms. Kosko told them that they need a motion.

Ms. Kosko went on to discuss the solar lights around the building. She stated that of the 25 lights, 18 are not functioning properly. She reached out to the company that they were purchased from and they are willing to help them with trouble shooting. She also contacted a local solar electrician that knows how to trouble shoot and work on this type of light fixture. She and Public Works are meeting with the company to try to get somebody out here to trouble shoot and fix each and every light. Ms. Kosko said they are looking at quite a substantial amount of money to fix the lights. She will have more information, hopefully for the next meeting. Mr. Fitzpatrick asked her to go back to find the research that was previously done on the lights and check to see what the cost of the repairs were then. Ms. Kosko said she had all that information and was aware of the results. Lastly, she announced the Tree Lighting and Party with Santa will be held on December 7<sup>th</sup> at 7 p.m. at the Municipal Building. The House Decorating Contest deadline is December 17<sup>th</sup> and judging will be held the week after. The Hainesport Fire Company will be taking Santa around town on December 22<sup>nd</sup> from 11 a.m. to 4 p.m. Anyone with questions should call Paula Tiver at the township.

**Mayor Masciocchi** thanked everyone for coming and told Zachary that he hopes he keeps up the great work. He also congratulated Gerry and Jim on the race and said he looks forward to working with both of them in the future. He followed the campaign and said the ideas that came out of it were really something to behold. The mayor wished everyone a Happy Thanksgiving and reminded them about Veterans Day.
