HAINESPORT TOWNSHIP COMMITTEE MINUTES December 11, 2018

7:00 P.M.

This meeting is called pursuant to the provisions of the Open Public Meetings Law. This meeting of December 11, 2018 was included in a meeting notice sent to the Burlington County Times and Courier Post On January 8, 2018 and advertised in said newspapers on January 11, 2018, respectively posted on the bulletin board in the municipal building on January 8, 2018 and has remained continuously posted as required under the Statute. In addition, a copy of this notice is and has been available to the public and is on file in the Office of the Municipal Clerk.

1. CALL TO ORDER by Mayor Masciocchi at 7:00 P.M.

2. FLAG SALUTE

 ROLL CALL - present were Committeewoman Gilmore, Committeewoman Schneider, Committeeman Costa and Mayor Masciocchi. Also present were Township Administrator/Clerk Paula Kosko and Attorney John Gillespie. Committeeman Fitzpatrick was absent.

4. PRESENTATION

- A. Fire Company to Governing Body Fire Chief Nick Macken came to thank the Township Committee for their financial support for the past year and he noted the various items that the company was able to purchase because of the support from the township. Chief Macken told them about the many hours of training the men were able to receive and also of the ability to send members to conferences. He said he always enjoys coming to the township building and lastly thanked the Hainesport residents for their generous support and how well they receive the firefighters around the township.
- B. Emergency Squad to Governing Body Donald Platt, Captain of the Emergency Squad, was at the meeting to address the Township Committee and the audience. He stated that they had lost some members from the squad but there were new members that have joined the squad. Mr. Platt told the committee the squad was grateful for the new ambulance they have with the automatic load litter. He thanked administration and staff for help received over the year. He also thanked the residents for their generous donations.

happens with that may have an impact on the other residents. He said he can't comment on the litigation.

Luis Lopez, 98 Levis Drive, Mt. Holly – asked if there was an update on the water main break on Parry Drive and was told that it was being taken care of. Ms. Schneider said they haven't been updated recently. He also asked what was happening with the Water Park/Resort and was informed that nothing was going to take place with it. Mr. Lopez wanted to know when the Reorganization Meeting would be and was told it will be on January 3, 2019. Mr. Lopez said he has had about 61 people thanking him for his work.

She also asked for approval to advertise in various entities for the position of CFO since our present CFO will be retiring in March.
