AN ORDINANCE ESTABLISHING A STOP INTERSECTION ON CREEK ROAD AS IT INTERSECTS HAINESPORT-MOUNT LAUREL ROAD

WHEREAS, the Hainesport Township Committee, is empowered under N.J.S.A. 39:4-201 and N.J.S.A. 39:4-197(2)a to designate through streets along Township Roads in order to protect the public and ensure safe roads within Hainesport Township; and

WHEREAS, the Hainesport Township Engineer has completed a survey of Creek Road; and

WHEREAS, recommendations have been made for the designation of STOP and THROUGH streets at each intersection; and

WHEREAS, all recommendations have been checked and/or revised by the Hainesport Township Engineer and finally agreed upon in text with the New Jersey Department of Transportation, Bureau of Traffic Engineering and Investigations.

NOW, THEREFORE, BE IT ORDAINED, by the Hainesport Township Committee, that all Township Roads at roadway intersections are hereby designated as THROUGH or STOP streets as follows:

Creek Road

Designated as an East/West Route.

A. Between Marne Highway (CR537) and Hainesport Mount Laurel Road (CR674).
