

**TOWNSHIP OF HAINESPORT
ORDINANCE NO. 2012-1-1**

**AN ORDINANCE APPROPRIATING FUNDING FROM THE CAPITAL IMPROVEMENT FUND FOR
RECREATION PROJECT EXPENSES AND PURCHASE OF REPLACEMENT VEHICLE**

BE IT ORDAINED by the Township Committee of the Township of Hainesport in the County of Burlington, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

Section 1. The improvements, purchases and expenditures described in Section 2 of this ordinance is hereby authorized to be undertaken by the Township of Hainesport. For the improvement or purpose described in Section 2, there is hereby appropriated a total sum of \$158,500 from the Township's Capital Improvement Fund.

Section 2. (a) The improvement, purchase or expenditure hereby authorized, and the purpose of the appropriation is as follows:

- i. Costs associated with Phase IV of the Recreation Complex Expansion Project. The total cost allocated for this expenditure is \$125,000.
- ii. Purchase of a four wheel drive vehicle. The total cost allocated for this expenditure is \$25,000
(b) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefore. The total amount authorized for the above mentioned projects is \$150,000.
- iii. Purchase of furniture and audio equipment needed for the Township meeting room in the amount of \$8,500.

Section 3. It is hereby determined and stated that the purchase set forth in Section 2 is a general capital expenditure and not a current expense.

Section 4. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

Section 5. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 6. This ordinance shall take effect immediately after proper passage, publication and approval as provided by law.
