# ORDINANCE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AMENDING RECORDS, PUBLIC ACCESS

**WHEREAS**, a need arises on occasion to the Township Committee of the Township of Hainesport to amend existing Ordinances; and

**WHEREAS**, the Township of Hainesport finds it in the best interest of the Township to amend certain provisions of the Records, Public Access Ordinance of the Township of Hainesport.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Hainesport that Chapter 138 entitled "Records, Public Access" is hereby amended as follows:

138-3C

- (3) For any letter of redemption certificate from the Tax Collectors Office that must be prepared, a fee of **\$50**.
- (4) Upon the request of a qualified person requesting a copy of a birth certificate, death certificate, marriage license certificate or domestic partnership certificate, the Clerk shall charge a fee of \$25 for the first certified copy of each and \$5 for each additional copy of each.

All other provisions of Chapter 138 Records, Public Access of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.
