#### ORDINANCE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AMENDING THE BUSINESS LICENSES

**WHEREAS**, a need arises on occasion to the Township Committee of the Township of Hainesport to amend existing Ordinances; and

**WHEREAS**, the Township of Hainesport finds it in the best interest of the Township to amend certain provisions of the Business Licenses of the Township of Hainesport.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Hainesport that Chapter 67 entitled "Business Licenses" is hereby amended as follows:

#### 67-5 License Fees

A License fee of \$50 for an individual and \$50 for corporations, partnerships and associations or joint venture shall be paid to the Township Clerk at the time the application is submitted to defray the costs of processing and investigation.

All other provisions of Chapter 67 Business Licenses of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.
