**ORDINANCE OF THE TOWNSHIP OF HAINESPORT,  
COUNTY OF BURLINGTON, STATE OF NEW JERSEY,  
AMENDING PEDDLING AND SOLICITING**

**WHEREAS**, a need arises on occasion to the Township Committee of the Township of Hainesport to amend existing Ordinances; and

**WHEREAS**, the Township of Hainesport finds it in the best interest of the Township to amend certain provisions of the Peddling and Soliciting of the Township of Hainesport.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Hainesport that Chapter 127 entitled “Peddling and Soliciting” is hereby amended as follows:

127-11 Fees

All applicants required to obtain a license under the provisions of this chapter shall pay a non-refundable application fee of \$50 per calendar year, which is determined to be the reasonable cost of investigation and processing of the application.

All other provisions of Chapter 127 Peddling and Soliciting of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.
