**ORDINANCE OF THE TOWNSHIP OF HAINESPORT,
COUNTY OF BURLINGTON, STATE OF NEW JERSEY,
AMENDING TOWNSHIP OF HAINESPORT CHAPTER 26
OFFICERS AND EMPLOYEES**

WHEREAS, a need arises on occasion to the Township Committee of the Township of Hainesport to amend existing Ordinances; and

WHEREAS, the Township of Hainesport finds it in the best interest of the Township to amend certain provisions of Chapter 26 Officers and Employees of the Township of Hainesport.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hainesport that Chapter 26 entitled “Officers and Employees” is hereby amended as follows:

Article I Officials, Employees, Boards and Committees

§ 26-1 Positions Enumerated

The officials, employees, boards and committees of the Township of Hainesport are as follow:

ADD: Township Administrator
Adult School Crossing Guard
Administrative Assistant
Clean Communities Coordinator
Director Public Works
Working Foreman
Acting Working Foreman
Class VII to Class I Laborer

New Section Added:

ARTCILE XII Public Works

§ 26-35 Positions Created

There is hereby created an employment position with the Township which shall be known as “Working Foreman”. Said position shall be a full-time employment position and is to be considered overtime non-exempt.

There is hereby created an employment position with the Township which shall be known as “Acting Working Foreman”. Said position shall be a temporary position and only occur in the absence of the “Working Foreman” and is to be considered overtime non-exempt.

There is hereby created an employment position with the Township which shall be known as Class VII to Class I Laborer. Said positions shall be a full-time employment position and is to be considered overtime non-exempt.

§26-36 Duties, Requirements, Knowledge, and Abilities

All the above shall be in keeping with Job Descriptions and as prescribed by Resolution 2015- established by the Township Committee.

§26-37 Rate of Compensation

Said rate of compensation shall be set by Hainesport Township Committee through a yearly Salary Ordinance establishing the Annual Rate of Compensation for Officers and Employees.

All other provisions of Chapter 26 Officers and Employees of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.
