AN ORDINANCE TO PROVIDE FOR AND DETERMINE THE RATE OF COMPENSATION OF OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF HAINESPORT

BE IT ORDAINED by the Township Committee of the Township of Hainesport in the County of Burlington and State of New Jersey as follows:

Section I – **Ordinance Amendments**

Section 1(a) of Ordinance 2014-4-5 and any subsequent amendments are hereby amended to read as follows:

Section 1(c) The provisions of this Ordinance of the Township of Hainesport shall be retroactive to and effective as of the first day of January 2015, unless otherwise stipulated by resolution, for all employees continuously employed by the Township of Hainesport from January 1, 2015 to the effective date of this ordinance.

Section II - Repealer

All ordinances or parts of ordinances are hereby repealed to the extent of such inconsistency.

Section III – Severability

The provisions of this ordinance are severable. If any provisions of this ordinance or its application to any person or circumstance is held invalid, said invalidity shall not affect any other provision of application of this ordinance which can be given effect without the provision or application of this ordinance.

Section IV – **Effective Date**

This ordinance shall take effect immediately after final passage and publication according to law.
