# TOWNSHIP OF HAINESPORT ORDINANCE NO. 2015-6-7

### AN ORDINANCE APPROPRIATING FUNDING FROM THE CAPITAL IMPROVEMENT FUND FOR THE PURCHASE OF TYPE III CLASS I EMERGENCY MEDICAL VEHICLE

- **BE IT ORDAINED** by the Township Committee of the Township of Hainesport in the County of Burlington, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:
- Section 1. The improvements, purchases and expenditures described in Section 2 of this ordinance are hereby authorized to be undertaken by the Township of Hainesport. For the improvement or purpose described in Section 2, there is hereby appropriated a total sum of \$150,000 from the Township's Capital Improvement Fund.
- Section 2. (a) The improvement, purchase or expenditure hereby authorized, and the purpose of the appropriation is as follows:
  - i. Purchase of a Type III Class I Emergency Medical Vehicle by Hainesport Township for use by the Hainesport Emergency Squad. The total amount allocated for this expenditure is \$150,000.
    - (b) The total amount authorized by the Township of Hainesport for the above mentioned project is \$150,000.
    - (c) Any and all additional costs exceeding \$150,000 shall be paid by the Hainesport Emergency Squad.
- Section 3. It is hereby determined and stated that the purchase set forth in Section 2 is a general capital expenditure and not a current expense.
- Section 4. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.
- Section 5. All ordinances or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.
- Section 6. This ordinance shall take effect immediately after proper passage, publication and approval as provided by law.
