TOWNSHIP OF HAINESPORT ORDINANCE 2016–1-2

ORDINANCE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AMENDING CHAPTER 85 FIRE PREVENTION

WHEREAS, a need arises on occasion to the Township Committee of the Township of Hainesport to amend existing Ordinances; and

WHEREAS, the Township of Hainesport finds it in the best interest of the Township to amend certain provisions of the Business Licenses of the Township of Hainesport.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hainesport that Chapter 85 entitled "FIRE PREVENTION" is hereby amended as follows:

85-4. License Fees

- <u>B.</u> The inspections of non-life-hazard uses as required by the Uniform Fire Code shall be conducted by the Fire Official and/or Fire Inspectors of the Township of Hainesport on at least a minimum of every other year.
- <u>D.</u> Churches shall be exempt from the payment of non-life-hazard registration fees; provided, however that churches shall not be exempt from any state-required fees.

85-8.Permit Fees

- B. The annual Township Business license fee shall be considered as satisfying a Type 1 permit where such permit is required as an operation of the business.
- C. Type 2, 3 or 4 permits which are not-integral to the business will be charged the applicable permit fee and be subject to an inspection as required under the Uniform Fire Code.

85-10. Key Lock box system.

- A. All newly constructed structures shall be equipped with a key lock box at or near the main entrance; All existing structures protected with an automatic fire suppression system, shall also have a locking type of cap on the Fire Department connection or such other location requiredan automatic fire alarm system or storage or use of hazardous materials shall also be equipped with the key lock box. In addition fire department connections may also be required to have locking caps if as determined by the Fire Official or the Fire Chief: Other uses requiring lock boxes are listed in (1), (2) and (3) below.
- B. All new structures subject to this section shall have the key lock box and locking Fire Department connection caps installed and operational prior to the issuance of an

occupancy permit. All installed lock boxes shall contain a current key, fob or some other method to enter the structure and/or business. All existing businesses subject to this section shall have 12 months to comply from the adoption of these amendments. The Fire Official or Fire Chief shall approve the type of key lock box system to be implemented within the Township of Hainesport.

All other provisions or sections of Chapter 85 FIRE PREVENTION of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.
