NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hainesport that Chapter 180 entitled "Vehicles and Traffic" is hereby amended as follows:

- 180-21 Establishment of Zones
 - A. A restricted parking zone, as permitted by N.J.S.A. 39:4-197.6, is authorized in front of the following residences:

(5) Justin M Seidle, 1623 Albert Street, Hainesport, New Jersey

All other provisions of Chapter 180 of the Vehicles and Traffic of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.
