## TOWNSHIP OF HAINESPORT ORDINANCE 2016 -7-5

## ORDINANCE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AMENDING TOWNSHIP OF HAINESPORT CHAPTER 26 OFFICERS AND EMPLOYEES

WHEREAS, a need arises on occasion to the Township Committee of the Township of Hainesport to amend existing Ordinances; and

**WHEREAS**, the Township of Hainesport finds it in the best interest of the Township to amend certain provisions of Chapter 26 Officers and Employees of the Township of Hainesport.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Hainesport that Chapter 26 entitled "Officers and Employees"" is hereby amended as follows:

Article I Officials, Employees, Boards and Committees

§ 26-1 Positions Enumerated

The officials, employees, boards and committees of the Township of Hainesport are as follow:

ADD: Registrar Deputy Registrar

New Section Added:

ARTCILE XIII Registrar/Deputy Registrar

§ 26-38 Positions Created

There is hereby created the positions of Registrar of Vital Statistics and Deputy Registrar of Vital Statistics. Said positions shall be a part-time employment and shall take an oath upon acceptance of the position.

§26-39 Registrar Duties, Requirements, Knowledge, and Abilities

The Registrar of Vital Statistics shall perform those duties prescribed by NJSA 26:8-25 as well as other duties as prescribed by the Township Committee.

§26-40 Deputy Registrar of Vital Statistics

The Deputy Registrar shall assist in the normal, day-to-day operation of the office and whose duty shall be to act in the registrar's stead in case of absence, disability or death of the registrar.

### §26-41 Rate of Compensation

Said rate of compensation shall be set by Hainesport Township Committee through a yearly Salary Ordinance establishing the Annual Rate of Compensation for Officers and Employees.

All other provisions of Chapter 26 Officers and Employees of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.
