ORDINANCE NO. 2017-12

AN ORDINANCE TO AMEND ORDINANCE 2017-4, ESTABLISHING SALARIES, WAGES AND COMPENSATION FOR EMPLOYEES OF THE TOWNSHIP OF HAINESPORT

WHEREAS, by Ordinance 2017-4, the Township Committee of the Township of Hainesport established certain salaries, wages and compensation for various officials and employees of the Township of Hainesport, and has now determined to allocate a salary to the position of "Clean Communities Grant Coordinator", the funds for which shall be paid directly from the grant monies received by the Township through that Clean Communities Grant Program.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Hainesport, County of Burlington, State of New Jersey as follows:

ARTICLE I. Position Established/Compensation.

A. Position Created.

There is hereby established the position of "Clean Communities Grant Coordinator", to both organize and submit the annual application to the Clean Communities Grant Program on behalf of the Township of Hainesport, and following receipt of the funds, to administer and implement same in accordance with the Township Committee's directions. A more specific job description shall be established by the Township Administrator and approved by Resolution of the Township Committee.

B. Compensation.

The compensation for the position of Clean Communities Grant Coordinator shall be equal to five percent (5%) of the Grant award, to be paid by no later than the second payroll following completion of CY grant administration.

ARTICLE II. REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. <u>Repealer</u>. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability</u>. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. <u>Effective Date.</u> This Ordinance shall take effect upon proper passage in accordance with the law, but shall be retroactive to January 1, 2017 so as to include the 2016 grant award.
