AN ORDINANCE AUTHORIZING EXECUTION OF EASEMENT GRANTING AND ACCEPTING RIGHTS IN PUBLIC AND PRIVATE PROPERTY

WHEREAS, the Township of Hainesport is the owner of certain real estate situated in and/or around the previously vacated "Industrial Boulevard", which property is part of the "Lawrence Boulevard Redevelopment Plan", adopted by Ordinance No. 2019-9, on October 8, 2019 by the Hainesport Township Committee; and

WHEREAS, Utility Easement Agreements between Zenith Properties, L.L.C., Seneca Properties, L.L.C. and the Township of Hainesport; as well as between Zenith Properties, L.L.C., Seneca Properties, L.L.C., the Township of Hainesport and CJ&M Associates of Hainesport, LLC, have been prepared and have been reviewed by the Township Attorney's office, which recommends the approval and execution of said Utility Easement Agreements; and

WHEREAS, the Township Committee of the Township of Hainesport determines it to be in the best interests of the residents and citizens to authorize the execution of said Utility

Easement Agreements, which are incorporated herein by reference.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township

Committee of the Township of Hainesport, County of Burlington, State of New Jersey that the attached Utility Easement Agreements, and described above, are hereby authorized to be executed by the Mayor and Township Clerk on behalf of the Township of Hainesport, and the

Mayor, Township Clerk, and Township Attorney and such other Township officials as may be appropriate and necessary, are hereby authorized to take such actions as are necessary to implement the terms of said Utility Easement Agreements for the benefit of Hainesport Township.
