ORDINANCE TO REPEAL CHAPTER 46 OF THE <u>CODE OF THE TOWNSHIP OF</u> <u>HAINESPORT</u> ENTITLED: "ALARM SYSTEMS"

WHEREAS, by Ordinance 1999-8-10 adopted on October 26, 1999, and Ordinance 1999-3-4 adopted on May 25, 1999, the Township adopted and established standards and regulations for certain alarm systems within the Township; and

WHEREAS, given the nature of the regulations and standards, and the absence of a municipal police department, the Township has not enforced this Ordinance for a number of years, and staff has, therefore, recommended the elimination of the Ordinance; and

WHEREAS, it appears that there is no means by which to regularly enforce the Ordinance, and therefore, the governing body agrees that it is appropriate to repeal the Ordinance.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Hainesport, County of Burlington, State of New Jersey that Chapter 46 of the Code of the Township of Hainesport, entitled: "Alarm Systems", be and the same is hereby repealed in its entirety.

BE IT FURTHER ORDAINED AND ENACTED that this Ordinance shall take effect upon proper passage in accordance with the law.
