

TOWNSHIP OF HAINESPORT

ORDINANCE NO. 2018-4

AN ORDINANCE TO AMEND ORDINANCE 2017-1, WHICH AMENDED THE CODE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY ELIMINATING HEALTHCARE BENEFITS FROM MEMBERS OF THE GOVERNING BODY

WHEREAS, by Ordinance 2017-1, the Township Committee of the Township of Hainesport established a limitation upon the provision of healthcare benefits for members of the governing body to terminate upon the conclusion of their existing terms as members of the governing body; and

WHEREAS, members of the Township Committee have requested that the Ordinance be amended to eliminate that benefits coverage prior to the expiration of an existing-members term.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hainesport, County of Burlington, State of New Jersey as follows:

Section 1 of Ordinance 2017-1 is hereby amended to now read as follows:

“The Township shall no longer pay the cost of healthcare benefits coverage, including, but not limited to medical and/or prescription drug benefits, for any eligible current Township Committeepersons, effective 90 days from introduction of this Ordinance, subject to such notice and/or disenrollment requirements of the State Health Benefits Program with regard to the actual termination of coverage as may apply”.

BE IT FURTHER ORDAINED AND ENACTED that this Ordinance shall take effect 90 days from the date of its introduction, subject to proper passage in accordance with the law; and any and all Ordinances inconsistent with the provisions hereof are hereby repealed to the extent of any such inconsistencies.


