**ORDINANCE OF THE TOWNSHIP OF HAINESPORT,  
COUNTY OF BURLINGTON, STATE OF NEW JERSEY,  
AMENDING CHAPTER 180 OF THE TOWNSHIP ORDINANCES  
ENTITLED VEHICLES AND TRAFFIC**

**WHEREAS**, a need arises on occasion to the Township Committee of the Township of Hainesport to amend and add to existing Ordinances; and

**WHEREAS**, the Township of Hainesport finds it in the best interest of the Township to amend certain provisions of the traffic ordinances of the Township of Hainesport; and

**WHEREAS**, the Burlington County Planning Board has recommended this regulation as part of its approval process for the Our Lady Queen of Peace Parish Center (Block 91, Lot 3).

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Hainesport that Chapter 180 entitled "Vehicles and Traffic" is hereby amended with a new addition as follows:

**ARTICLE VIII: STREETS AND TURNS**

**180-23 TURNS**

B. No person shall make a left turn on any street or parts of street listed below and made a part of this chapter.

1. Onto County Route 537 (Marne Highway) from Our Lady Queen of Peace Parish Center (Block 91, Lot 3) located 300 feet southwest of the intersection of Broad Street/County Route 641 (Hainesport-Lumberton Road) and County Route 537 (Marne Highway).

All other provisions of Chapter 180 of the Vehicles and Traffic of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.


