**ORDINANCE OF THE TOWNSHIP OF HAINESPORT,  
COUNTY OF BURLINGTON, STATE OF NEW JERSEY,  
AMENDING CHAPTER 67 BUSINESS LICENSES**

**WHEREAS**, a need arises on occasion to the Township Committee of the Township of Hainesport to amend existing Ordinances; and

**WHEREAS**, the Township of Hainesport finds it in the best interest of the Township to amend certain provisions of Chapter 67 Business Licenses.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Hainesport that Chapter 67 entitled "Business Licenses" is hereby amended as follows:

§ 67-8 Term of license; application for renewal.

A license issued for 2016 shall not expire to July 31, 2017 and thereafter when issued shall be valid through the month of July in the calendar year following the year in which the license is issued, unless sooner terminated by revocation pursuant to the terms of this chapter. No later than June 1 of each year, the holder of a license shall make application to the Township of Hainesport for its renewal. Application for a renewal shall follow the same procedures and requirements as set forth for a new application and shall require the same procedures, consideration and determination by the Township Committee in the same manner as a new application.

All other provisions or sections of Chapter 67 BUSINESS LICENSES of the Township of Hainesport shall remain in full force and effect; however any Ordinances or parts of Ordinances inconsistent with the provisions of this ordinance as amended are hereby repealed to the extent of said inconsistency.

This Ordinance shall take effect immediately upon final passage and the publication in accordance with the laws of the State of New Jersey.
