

**TOWNSHIP OF HAINESPORT**

**ORDINANCE NO. 2017-2**

**AN ORDINANCE TO PROVIDE FOR COMPENSATION FOR THE POSITION  
OF FIRE OFFICIAL FOR THE TOWNSHIP OF HAINESPORT**

**WHEREAS**, Resolution 2017-44-1, the Township Committee appointed a municipal fire official, and set forth the salary of Seventeen Thousand Five Hundred Dollars (\$17,500.00); and

**SECTION ONE.** Salary established. There is hereby established for the position of fire official for the Township of Hainesport, an annual salary of Seventeen Thousand Five Hundred Dollars (\$17,500.00) in recognition of the part-time nature of the fire official position.

**SECTION TWO. REPEALER, SEVERABILITY AND EFFECTIVE DATE.**

**Repealer.** Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.

**Severability.** In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.

**Effective Date.** This Ordinance shall take effect upon proper passage in accordance with the law.
