AN ORDINANCE TO AMEND CHAPTER 104 OF THE <u>CODE OF THE TOWNSHIP</u> <u>OF HAINESPORT</u> SPECIFICALLY SECTION 104-123 RELATING TO "SIGNS"

BE IT ORDAINED AND ACTED by the Township Committee of the Township of Hainesport, County of Burlington, State of New Jersey that:

ARTICLE I. AMENDED SECTIONS. Section 104-123, "Signs", is hereby amended as follows:

- A. Section 104-123(M)(6)(b) is hereby amended to read as follows:
 - "(b) Location of Billboard Signs. An outdoor billboard sign shall be permitted as a conditional use in the I-1 zone and on Township-owned property in any commercial or highway zone, and shall be located in accordance with the regulations set forth below."

ARTICLE II. REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. <u>Repealer</u>. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability</u>. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. <u>Effective Date</u>. This Ordinance shall take effect upon proper passage in accordance with the law.
