

**TOWNSHIP OF HAINESPORT  
ORDINANCE NO. 2019-4**

**AN ORDINANCE TO PROVIDE FOR AND DETERMINE  
THE RATE OF COMPENSATION OF OFFICIALS AND  
EMPLOYEES OF THE TOWNSHIP OF HAINESPORT**

**BE IT ORDAINED** by the Township Committee of the Township of Hainesport in the County of Burlington and State of New Jersey as follows:

**Article I – Ordinance Amendments.** Ordinance 2018-5 as subsequently amended is hereby further amended to establish the following rates of compensation of Officers and Employees whose compensation shall be on an annual basis, except as specified otherwise:

## **Article II – Repealer**

All ordinances or parts of ordinances are hereby repealed to the extent of such inconsistency.

## **Article III – Severability**

The provisions of this ordinance are severable. If any provisions of this ordinance or its application to any person or circumstance is held invalid, said invalidity shall not affect any other provision of application of this ordinance which can be given effect without the provision or application of this ordinance.

## **Article IV – Effective Date**

This ordinance shall take effect immediately after final passage and publication according to law, but shall be retroactive to and effective as of the first day of January 2019, unless otherwise stipulated by resolution, for all employees continuously employed by the Township of Hainesport from January 1, 2019 to the effective date of this ordinance.


## NOTICE OF PUBLIC HEARING


