ORDINANCE NO. 2019-7

ORDINANCE TO AMEND CHAPTER 161 OF THE <u>CODE OF THE TOWNSHIP OF HAINESPORT</u>, ENTITLED "STORMWATER MANAGEMENT"

WHEREAS, the improper discharge of water onto Township streets creates hazards on public streets and sidewalks; and

WHEREAS, stormwater improperly discharged across property lines creates a nuisance for neighboring property owners; and

WHEREAS, the Township Committee of the Township of Hainesport desires to amend the <u>Code of the Township of Hainesport</u> to address these concerns.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Hainesport, County of Burlington, State of New Jersey as follows:

I. AMENDED SECTIONS

Chapter 161 of the <u>Code of the Township of Hainesport</u> entitled "Stormwater Management" is hereby amended as follows: [newly added material is indicated by <u>underlined</u> text; deletions are indicated with strikethrough]:

[§§161-1 and 161-2 to remain unchanged.]

§161-3 Prohibited conduct

[Subsections §161-3(A) through §161-3(D) to remain unchanged.]

- F. Improper disposal of <u>stormwater</u> waste. <u>The following actions shall constitute a violation of this section:</u>
 - a. The Spilling, dumping, or disposal of materials other than stormwater in the municipal separate storm sewer system operated by Hainesport Township is prohibited. The spilling, dumping, or disposal of materials other than stormwater in such a manner as to cause the discharge of pollutants to the municipal separate storm sewer system is also prohibited.
 - b. Discharging stormwater across property lines and public sidewalk.
 - c. Extending a sump pump hose, or other water displacement hose, across a public sidewalk.

- d. Discharging water onto a public street more than six (6) feet from the curb line.
- e. <u>Cutting, breaking, or otherwise damaging the concrete and/or Belgian block of a public street or side-walk to facilitate water discharge without a road-opening permit.</u>

[Subsections $\S161-3(F)$ through $\S161-3(H)$, and Sections $\S161-4$ through $\S161-16$ to remain unchanged.]

ARTICLE II. REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. <u>Repealer</u>. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability</u>. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. <u>Effective Date</u>. This Ordinance shall take effect upon proper passage in accordance with the law.
