**AN ORDINANCE OF THE TOWNSHIP OF HAINESPORT,
COUNTY OF BURLINGTON, NEW JERSEY,
APPROPRIATING THE SUM OF \$190,000 IN FUNDING
FROM THE CAPITAL IMPROVEMENT FUND FOR THE
PROJECT KNOWN AS SIDEWALKS, CURBS, WARNING
SURFACES AND STRIPING ON WASHINGTON AND
BROAD STREET AND VARIOUS PARKS AND
RECREATION PROJECTS.**

**BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF
HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AS
FOLLOWS:**

Section 1. There is hereby appropriated the sum of \$190,000.00 from the Capital Improvement Fund in the Township of Hainesport, County of Burlington, New Jersey ("Township") for the following purposes:

Section 2. It is hereby determined and stated that the improvements set forth in Section 1 are General Capital Improvements and not a current expense.

Section 3. The Capital Budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

Section 4. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This ordinance shall take effect after final adoption and publication as required by law.




