ORDINANCE NO. 2021-2

AN ORDINANCE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY ADOPTING REDEVELOPMENT PLAN FOR CERTAIN PROPERTY KNOWN AS BLOCK 42, LOTS 1, 1.01, 1.03, 2 AND 2.01

WHEREAS, the Township Committee of the Township of Hainesport ("Township") following referral to and upon recommendation of, the Hainesport Township Planning Board ("Planning Board"), desires to adopt the "Route 38-Mount Holly Bypass" for a certain area in need of non-condemnation redevelopment at Block 42, Lots 1, 1.01, 1.03, 2 and 2.01, within the Township of Hainesport, Burlington County, New Jersey, which Plan has been prepared by The Taylor Design Group, dated January 27, 2021, and is incorporated herein and made a part hereof by reference; and

WHEREAS, the Planning Board has examined and considered said proposed

Redevelopment Plan regarding the subject designated non-condemnation redevelopment area;

and

WHEREAS, the Planning Board conducted a public meeting on February 3, 2021 concerning the Plan, which was open to the public and where said Plan was explained and discussed and members of the public had an opportunity to pose questions and submit concerns; and

WHEREAS, the Planning Board has, through Resolution No. 2021-04, reported that the proposed Plan is consistent with the Township Master Plan and has recommended that the Plan be adopted by the Township Committee; and

WHEREAS, the Plan, upon adoption by this Ordinance, is expected to facilitate redevelopment/development of the non-condemnation redevelopment area, and to provide new

opportunities for economic growth for the community.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Township

Committee of the Township of Hainesport that, with the recommendation of the Planning Board to adopt the proposed "Route 38-Mount Holly Bypass", such recommendation is accepted and the Plan is hereby adopted, including any necessary overlay zoning regulations contained therein.

BE IT FURTHER ORDAINED by the Township Committee of the Township of Hainesport that the Redevelopment Plan prepared by Taylor Design Group for the subject non-condemnation redevelopment area, be and hereby is adopted to govern the Redevelopment Area comprised of Block 42, Lots 1, 1.01, 1.03, 2 and 2.01.

BE IT FURTHER ORDAINED that any prior Ordinances or Plans which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistencies.

BE IT FURTHER ORDAINED that this Ordinance shall become effective following final passage and publication as required by law, as the Ordinance adopting the Redevelopment Plan for the designated area, and zoning and redevelopment maps for the area, as applicable.
