ORDINANCE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, NEW JERSEY, APPROPRIATING THE SUM OF \$725,000 IN FUNDING FROM THE GENERAL CAPITAL FUND BALANCE FOR VARIOUS PROJECTS THROUGHOUT THE TOWNSHIP

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AS FOLLOWS:

Section 1. There is hereby appropriated the sum of \$725,000.00 from the Capital Fund Balance in the Township of Hainesport, County of Burlington, New Jersey ("Township") for the following purposes:

a.	Municipal Hockey Rink	\$150,000.00
	Computer Hardware/Software	10,000.00
c.	Purchase of Fire Equipment	15,000.00
d.	Creek Turn Park Improvements	250,000.00
e.	Chase Park Improvements	100,000.00
f.	Fire Apparatus	100,000.00
g.	Bucket Truck	100,000.00
	Total	\$725,000.00

Section 2. It is hereby determined and stated that the improvements set forth in Section 1 are general capital improvements and not a current expense.

Section 3. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

<u>Section 4.</u> All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This ordinance shall take effect after final adoption and publication as required by law.
