

**TOWNSHIP OF HAINESPORT  
ORDINANCE NO. 2016-9-6**

**AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, ELIMINATING HEALTHCARE BENEFITS FOR MEMBERS OF THE GOVERNING BODY RETIRING OR ENDING SERVICE.**

THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HAINESPORT, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, DOES ORDAIN:

**STATEMENT OF PURPOSE**

The purpose of this ordinance is to eliminate and discontinue the payment of premium health benefits coverage, including but not limited to medical and/or prescription drug benefits, by the Township for any elected official who retires or otherwise ceases to serve as an elected official after the adoption of this Ordinance upon second reading. It is the intent of this Ordinance to modify and revise the Township's Code as well as any Ordinance, Resolution or policy in any form, to achieve that purpose.

**SECTION I**

As of the effective date of this Ordinance, the Township shall no longer pay the cost of premium health benefits coverage, including but not limited to medical and/or prescription drug benefits, for any elected official who retires or otherwise ceases to serve as an elected official.

**SECTION II**

Any contrary Township Code, Ordinance, Resolution or policy in any form, whether stated directly within one of the aforementioned or incorporated by reference, in whole or in part, is hereby repealed and shall be stricken.

**SECTION III**

Each section of this Ordinance, and each section contained within the Township's Employee Handbook or Personnel Manual to the extent adopted by or revised by Ordinance, is an independent section, and if a legally binding determination is made that any section, part, clause, word or portion thereof is unconstitutional, illegal, unenforceable, void or ineffective, then that item shall be severable from the balance and shall not be deemed to affect any other sections or portion thereof.

**SECTION IV**

All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency.

## **SECTION V**

This ordinance shall take effect after the first publication thereof after final adoption according to law.
