BRUSH PICK-UP SCHEDULE & INFORMATION

Hainesport residents often boast about how responsive their township is when a request for service is made or when there is a personal visit to the municipal building. Well, it is true! The township strives to uphold our motto of being a *'Community of Excellence'*. This is more than a catchy phrase. It is exactly what we see as we all travel through our neighborhoods and township. We want to continue to be an excellent community and provide you with services as efficiently and effectively as possible. We need your help to maintain this as it relates to brush pick-up.

Beginning October 5, 2020, there will be a Zone Schedule for brush pick-up. Zone 1 brush pick-up will be the first full week of the month (full week begins on Monday). Zone 2 will be the second full week and Zone 3 will be the third full week. Please see the attached township map reflecting each of the three zones and 2020 schedule. Brush can be placed in front of your property **no sooner than** the weekend before your scheduled pickup. There are reasons why this request is highlighted and a schedule is being created. Below are several reasons:

- Brush is being placed on public roadways by residents on a frequent, regular basis often creating hazardous conditions.
- Continuous unsightly piles of brush and vegetation are a blight to the neighborhood and community.
- Public works picks up debris for residents and soon or immediately after, more debris is replaced at the curb.
- Hainesport Township is responsive to 2,286 households and having a schedule will help us provide services efficiently and equitably.
- Everyone wants to be first on the list but that is an impossible feat for even our hardworking, dependable public works crew.

We regularly receive inquiries about what defines and what to do with brush, leaves, grass, bulk trash and white goods. Please find below information on the residential collection for each of these items. Please keep all items a minimum of 10 feet from storm drains (NJDEP rule), mailboxes and poles.

Brush Collection

- Is considered to be shrubs, hedges, garden debris, mulch, stumps and tree limbs up to 10” in length
- Do not combine brush with leaves. We use two different machines for these and they both go to different locations.
- Contractors/professionals removing or trimming trees are responsible for disposal of all vegetative debris.
- It is the property owner’s responsibility to dispose of vegetative debris and trees generated by lot clearing.
- If there is an issue with your brush out for municipal collection, it will be tagged with a written explanation.
- Please place brush in front of your property.
- No brush collection in November and December (unless there is a storm event that requires it).

Grass Clippings

- Place grass in **plastic bags** weighing no more than 30 pounds per bag. Paper bags get wet from rain, irrigated water and disintegrate when picked up.
- Grass can be placed with household trash.
- We strongly encourage residents to utilize mulching mowers, leave clippings in place or use clippings as a composting source for enriched soils.

Leaves

- During the Spring months of March, April and May and the Fall months of October, November and December leaves can be placed at curb loose. The leaf vacuum machine will remove these piled leaves.
- Please **paper bag** leaves during the months of January, February, June, July, August and September. Our drop-off source will only accept paper-bagged leaves. Bags can be purchased at local hardware stores.
- Do not mix twigs larger than 1” in diameter, branches, mulch, dirt or any other materials with your leaves.

Appliance/Metal & Bulk Items for *Municipal* Collection

- These items are picked up on Mondays.
- Call us for pick-up and place curbside Sunday evening.
- Includes major appliances that have coolant such as air conditioners, dehumidifiers, refrigerators, freezers.
- Includes pallets, *pressure treated* wood and fencing (cut in 4 foot lengths and bundled/tied), televisions*, computers*.
- Disassembled wood and metal swing sets and small sheds – must be in 4-foot sections and bundled.
- Move outs and home flipping-generated waste (household or bulk) is the responsibility of the homeowner.

Bulky Waste for Weekly *Trash* Collection

- Includes wood and upholstered furniture, small appliances, bedsprings, mattresses. **One item per collection.**
- Bulky construction material such as plasterboard, dry wall, carpet, building materials resulting from home remodeling and home repair work done **by homeowner only**. Contractor must remove materials generated by contracted work.
- Carpet, wood (no pressure treated), boards, dry wall must be bundled in 4-foot sections or less. 2-3 bundles will be accepted at a time.
- Construction debris shall be stored in acceptable trash containers, weighing no more than 30 pounds. No more than a total of 60 pounds per collection.
- Intact glass must be taped on all sides and the middle to secure from breaking and protect hauler. Broken glass must be put in a closed plastic bin to protect hauler from being injured.
- Move outs and home flipping-generated waste (household or bulk) is the responsibility of the homeowner.

Recycling Drop-Off Center – 100 Broad Street

- Residents only. No contractors.
- Has 24-hour surveillance for monitoring illegal dumping which also includes contractor dumping.
- Electronics Bin (televisions, computers).
- Small electronics such as CD players, fax machines, stereos, coffee pots, toasters, etc. can be placed with your residential trash.
- Paint Bin – cans must be sealed. If there is a small amount of paint in the can, dry it out and throw away with household trash.
- Oil Bin – waste oil must be in a closed container.
- Cardboard Bins.
- Absolutely no bulk items, household waste or appliances are to be dropped off at this location.

* These items can also be taken the Recycling Center Drop-Off located at 100 Broad Street
