Mr. Clauss stated that he had a problem with this being an earmark with a Congressman which equates to pork. We should be getting this money from our local Commissioners. He thinks this is no more than a political ad for the Congressman trying to take advantage of us. He does not like the fact that it was put on the agenda last minute without time to properly review it and this was done last month as well. **Mrs. Evans** asked how is it taking advantage of us if we are getting money. Mr. Clauss answered that just because we are getting money does not make it right. The rest of the people in the United States are being taken advantage of. Mrs. Evans said this is available nationwide. Community project funding is not just in New Jersey. **Mrs. Tordy** commented that she does not like the fact that this is coming from the federal government, but she knows we do not get anything from our Commissioners and we need the money for the park.

12. COMMENTS FROM THE ADMINISTRATOR

Ms. Kosko announced that we received a \$63,000 award for the American Rescue Plan Firefighter Grant that the Committee approved application to a few months ago. The money will be used to purchase firefighter PPE and replace the oxygen fill tank at the firehouse. We did commit a \$10,000 match, but we provide them with Capital funding on top of their regular allocation so that can be used for their match.

She had a very productive meeting with the Hainesport Fire Company President Mike Houlihan and Assistant Fire Chief Chris Lippincott to discuss the LOSAP program. Some amendments need to be made to add the Fire Police and correct the point allocation. We will be presenting it next month. We will introduce the budget in April and adopt in May.

We submitted the Green Acres Grant application. She thanked Michelle Taylor for all her work on the grant document. We are requesting the maximum amount of \$700,000 which comes with a match of \$250,000 that was budgeted last year in the capital budget. There will be a request for the remaining match in this year's capital budget to go towards this project at Creek Turn Park. This is for Phase I. The expected cost for Phase I is between \$1.2 - \$1.4 million dollars. If we get the federal funding, that will help support Phase II. If we do not get the money from the state for Green Acres, we can utilize the money from the feds to get the project going.

She apologized for Resolution 2024-63-3 arriving last minute. There is a short timeline to submit these requests. We have already committed funds on the writing of the Green Acres Grant application which is over 250 pages long. We can capture that work and utilize that information for the federal earmark money request. She did not want to wait and possibly miss the opportunity for this additional funding request.

Committeewoman Tordy – wished Hainesport a happy anniversary and birthday. She welcomed all that came to the meeting. Our 100th anniversary celebration is off to a wonderful start. She thanked all the people that pulled the event together – especially Sue Derickson as the unsung hero for helping with the events. She thanked everyone for their generous support of the Tea and Fashion Show. We had 77 baskets to raffle and raise money for our June celebration. She thanked Bradford Estate, Kelli's Kandies, BCIT for the programs, Browse Around Shop, J-Suites, the Ladies Auxiliary and all those who donated and helped with the event. We have samples on the desk of our 100th anniversary t-shirts. We will have them for sale as a fundraiser.

She congratulated Hainesport School on their wonderful talent show. She and Mayor Gilmore attended. They were impressed with all the talent. She attended municipal and budget classes for the township. She announced Storytime this Friday at 10 am at the Street Center and the Easter Egg event is Saturday, March 23rd. She wished all a Happy Ramadan and Easter.

Committeewoman Evans – corrected Mrs. Tordy that the dance was an "adult" dance, not a "senior citizen" dance. She is grateful to see all the grant awards going in to get money for Creek Turn Park development. She is also grateful to be representing the community during this exciting 100th anniversary celebration.

Committeeman Clauss – said he is proud to be in Hainesport for both the 50^{th} and the 100^{th} anniversary. He commented on the grant that just because money is free does not make it right. That is why we have a deficit that is out of control in the

federal government. He hopes local funding becomes available for the park. He wished Hainesport a happy anniversary.

Committeeman Montgomery – Wished Hainesport a happy anniversary. He is happy to be a part of it all. He attended the tea and fashion show. It was a wonderful event. He thanked the volunteers, student models and attendees. He encouraged everyone to get involved in the town's activities and support our fundraisers. Our garden flags are on sale for \$20. We are still selling tickets to raffle off a hot air balloon ride. He went to the ribbon cutting for Woods Machinery. It is a great business and he is profitable already. He agrees with Mr. Clauss about the grant request, but supports the resolution because we have lost so much funding from the state. He wished all a Happy Ramadan, Easter and Happy St. Patrick's Day. He reminded everyone that April 20th is Clean Up Day and shredding for the township.

Mayor Gilmore – thanked everyone that showed up to the Grand Opening at Woods Machinery. She enjoyed the talent show. She thanked everyone for coming the meeting tonight. She thanked the students that submitted their artwork for the 100th celebration. She hopes they continue to do other events for the anniversary such as the walking tour and the June 1st event.
