HAINESPORT TOWNSHIP COMMITTEE SPECIAL MEETING MINUTES

March 5, 2018

6:00 P.M.

This special meeting was called pursuant to the provisions of the Open Public Meetings Law. Notices of the meeting were sent to the Burlington County Times and the Courier Post on February 15, 2018. In addition copies of the notices was posted on the bulletin board in the Municipal Building and filed in the office of the Municipal Clerk on the aforementioned date. 5. **COMMENTS FROM THE PUBLIC (Comments are limited to 5 minutes)**

Anna Evans, 63 Parry Drive – researched the five Planning candidates over the weekend. Mrs. Evans reminded the committee of the issue where Alaimo Engineers gave funds to her political competitor's and the republicans campaign. In 2016, ERI earned 4.6 million and gave \$76,800 in donations to a PAC; CME Associates earned 34.7 million and gave \$375,000 in donations to political campaigns; CGP&H earned 1.5 million in municipal contracts and gave \$17,350 in donations to political campaigns. She does not want to see donations wind up in Ted Costa's campaign or the Republicans. She had the chance to chat with planner Tom Scangarello while waiting in the lobby. He stated he never donates a cent to political campaigns. She wants to see the dirty money out of Hainesport. She is requesting this to be considered with the decision to hire the new planner.
