#### 6. DISCUSSION/PRESENTATION

**Presentation by Scott Taylor regarding ORDINANCE 2021-6** – Adopting Redevelopment Plan for Certain Property Known as Block 103.01, Lots 1 and 8 and Block 113, Lot 4.05.

**Scott Taylor** explained the ordinance is adopting a redevelopment plan for the area known as the Longbridge Redevelopment Area. The plan has been examined by the Joint Land Use Board, explained and discussed with members of the public and that it will facilitate development by non-condemnation and provide new opportunities for economic growth for the community. The designated area includes parcels A, D and Q, as identified in the Plan and redevelopment area maps, which is predominantly known as the Longbridge Farms Property. The Plan has been prepared in accordance with the Local Redevelopment and Housing Law, it sets forth the basis for the goals for the redevelopment area, it has been determined to be consistent with the Master Plan and establishes modified zoning for the three parcels. This plan allows for 3 single family homes along Mt. Laurel Road, a majority of the Highway Commercial District would remain intact, but behind the single family homes, with access only by Hainesport Mt. Laurel Rd., will be a Townhouse Zoning District that would allow for up to 45 townhouses. This is set forth as a new zone known as the Longbridge Redevelopment Area Townhouse (LRAT) Zoning District. There will be a required 15% affordable housing set aside with the townhouse development. Standards are also set up for the Longbridge Redevelopment Area Highway Commercial Zoning District. The permitted uses have been expanded from the standard Highway Commercial Zoning District to allow for micro-breweries as well as conditionallypermitted uses including fast food and fuel service with convenience with significant landscape buffer and design. There will be an enhanced landscape and buffer plan for both the Townhouse and Highway Commercial Zoning Districts as well as lighting, maintenance requirements and the like. Also allowed in the Highway Commercial District are indoor recreation facilities under 10,000 sq. ft in area. Health and fitness facilities such as gyms, yoga studios, dance studios, and the like are included. All of this is to capitalize on the Route 38 corridor by stimulating ratable growth in the township. **Committeeman Montgomery** asked if full size restaurants, a level up from fast food, is allowed in the Highway Commercial area. Scott Taylor explained that the ordinance already allows for restaurants, He added that the Plan also allows for congregate care facilities such as a convalescent center or a senior living facility. Mayor Gilmore opened it up for any public comments. There were no comments.

We do lien the property \$300 each time the grass is maintained. Due diligence on our part with certified letters etc. has already been done so this resolution is for approval to place a municipal lien on the property.

12. COMMENTS FROM THE PUBLIC (Comments are limited to 5 minutes) Anna Evans, 63 Parry Drive – Said she was very pleased to see that there is a 15% affordable housing set aside in the redevelopment plan because this is what affordable housing should be. They should be right there with the other housing rather than in its, for a lack of a better word – 'ghetto', and this is a step in the right direction. She asked if the cannabis meeting advisory group would be reporting back to the us. Mayor Gilmore explained that they would be reporting back to the township committee who would in turn report back to the public. Anna asked when the next opportunity is for the township to opt in on the cannabis business. Mayor Gilmore commented that we have not even adopted it yet. John Gillespie replied that there will be plenty of time to opt in. There currently is an August deadline for opting out but we are still waiting for state guidelines and hope the regulations get promulgated sometime by the end of the summer. Anna also commended Committeeman Clauss for calling in from his vacation and she wished Mayor Gilmore a Happy Birthday. Mayor Gilmore stated that Mr. Scott Taylor and Zoning Officer Kathy Newcomb are part of the Cannabis Advisory Committee and they will be talking about a lot of things. Committeeman Montgomery made the recommendation that everyone in

attendance at the meeting sing Happy Birthday to the Mayor. **All in attendance** sang Happy Birthday to Mayor Gilmore.

Mayor Gilmore invited SSgt. Antennucci to give his report at this time.

**Ssgt. Antennucci** reported that there was nothing major to report in town with regards to crime. There have been no issues with Tavern & Table and the troopers are still patrolling that area. The Tavern & Table staff have been very supportive of the troopers and thanked them for their extra patrols. In June, there were reports of a suspicious white male traveling around in a beige Nissan Altima in residential areas. He was approaching adult and juvenile females asking to use their phone and bathroom. There was no crime committed and has been no further reports or development of this matter since then. Just reminded residents to be mindful of their children and who they talk to. He also wanted to remind residents of the statewide trend of catalytic converters being stolen and be mindful of this. Troopers continue to make arrests and close out vehicle burglaries attributing to an interstate theft ring. The troopers attended Community Day and the Concert in the Park and are interested in the August tennis event.

#### 13. COMMENTS FROM THE ADMINISTRATOR

Ms. Kosko said the Fiscal Year 2022 DOT Municipal Aid Grant was submitted on June 28<sup>th</sup> for Pulaski Avenue, Laurel Ridge and Fenimore Roads improvements. Our grant requested amount is \$498,000. The Green Acres grant application will be submitted tomorrow or Thursday which includes various municipal park improvements including trail flooding mitigation, concession stand and restroom upgrades and the installation of an internal walking trail loop so trail users can avoid entering school property during school hours. CGP&H has been helping with the grant but she would also like to thank Taylor Design Group, Scott Taylor and Steve Lennon for stepping up at the last minute, helping with gathering information, doing a site visit, taking pictures and writing portions of the grant. It was a lot more work than was anticipated and wanted to say thank you again. She also stated that public works employee, Jeff Crain, has submitted an extensive, thorough and very-well written and organized Sidewalk Assessment of all sidewalks in the township. She will be able to present the information at the August meeting. She would like to commend him on such a great job with this project. Committeeman Montgomery said he is stepping up very nicely in his new role and kudos to him. Ms. Kosko said that we have a meeting with the My Downtown App, which is for a mobile app for the project that we want to implement for the residents to be better connected to the township in another way other than the website. This is our second mobile app company we are meeting with and hopefully, we will have something to present at the next meeting for your consideration. She states that maybe the American Rescue Plan funding can be used for this. And finally, most importantly, Happiest of Birthdays to Mayor Gilmore.

#### 14. COMMENTS FROM THE SOLICITOR

**Mr. Gillespie** said he went to the Burlington County BAR Association picnic a couple weeks ago and a couple of the attorneys and judges were talking about their pickle ball experiences and were unanimous in opinion on the superiority of

Hainesport's Pickle Ball Courts. **Committeeman Montgomery** said that Mike Golenda has helped start this craze a number of years ago and has worked with the kids and really helped push for this as well as many other people. **Mr. Gillespie** also wanted to join everyone else in saying Happy Birthday Mayor.

**Committeeman Montgomery** wished Mayor Gilmore a happy birthday and wanted to wish his youngest daughter a happy birthday.

**Committeeman Clauss** also wished the Mayor a happy birthday. He said he is very happy with the public works department and they are doing a great job and thanked the Fire Company and EMS in Hainesport and everyone have a good night.

**Mayor Gilmore** thanked Jennifer for filling in tonight for Tara who couldn't be here and welcomed her, she is our newest permanent employee. We did have our first concert in the park and it was sponsored by Taylor Design Group with a huge turnout of about 300 people. The next concert is this coming Sunday, July 18<sup>th</sup> and it is the Charlie Zahn & Tad Marks group and it is sponsored by Parker McKay. Also the senior citizens have a meeting on July 22<sup>nd</sup> at the Street Building. The Senior Citizens Vintage Dance and Ice Cream Social is a new event for resident's age 55 years and older. It will be held August 13, 2021 at 6:30pm. Sign up by July 30, 2021. There is more information on the website or you can call Donna Casey at the township, ext. 121 for more information. This is in place of the Senior Citizens Prom that was two years ago and was a very successful event.
